**Notes to Applicants**

1. The Communication Platform aims to provide a collaborative platform to link up various stakeholders in the green maritime fuel supply chain, with a view to establishing an ecosystem for green maritime fuel-related business in Hong Kong, thereby facilitating the development of Hong Kong as a green maritime fuel bunkering and trading centre. The terms of reference of the Communication Platform are at **Annex**.
2. Applicants must be Hong Kong-registered companies or trade associations (but not academic institutions, think tanks or other groups) with substantive business, existing or prospective, related to green maritime fuel bunkering and/or trading.
3. The Transport and Logistics Bureau (“TLB”) retains the final authority to approve or reject applications.
4. The Communication Platform will organise various meetings or activities (see **Annex**), with members of the Group to be invited in a bespoke manner, i.e. members may be invited to some activities but not others, depending on the nature of the activities. Invitations will be extended by the sole discretion of the TLB.

## **Green Maritime Fuel Development Communication Platform Terms of Reference (ToR)**

The Green Maritime Fuel Development Communication Platform (“Communication Platform”) is an industry consultative body, to be chaired by the Commissioner of Maritime and Port Development of HKSARG and joined as members by relevant Government departments (such as the Marine Department, Environment and Ecology Bureau, Fire Services Department and Electrical and Mechanical Services Department) and industry stakeholders including green maritime fuel producers, users, bunker operators, port operators and ancillary service providers, to advise the Government on the development of Hong Kong into the region’s most preferred green maritime fuel bunkering and trading centre.

The Communication Platform shall meet once a year regularly, with additional ad hoc meetings and activities<sup>1</sup> on a need basis, and advise TLB on –

- a. the focus areas and priorities for facilitating the development of the green maritime fuel industry in Hong Kong, including the implementation and fulfilment of targets, strategies and measures along those announced in the Action Plan on Green Maritime Fuel Bunkering;
- b. strategies and measures to promote the quality development of green maritime fuel bunkering in Hong Kong, including the enhancement of relevant bunkering capabilities and fostering of a comprehensive ecosystem development;
- c. strategies and measures to foster closer industry collaborations and encourage the organic and effective development of green maritime fuel trading in Hong Kong; and
- d. other matters related to green maritime fuel.

<sup>1</sup> Such activities may include –

- Regular annual meetings: to reflect views on industry development and relevant policies to the Government to facilitate the latter’s policy formulation
- Networking and business matching events (e.g. seminars, conferences): to gather stakeholders and create opportunities for them to discuss collaboration
- Visits to green maritime fuel-related facilities: to learn about the green credential of various parts of the green maritime fuel supply chain, and network with relevant stakeholders through site visits or meetings
- Small group meetings: bespoke meetings engaging relevant stakeholders to discuss business proposals with Government facilitation
