Note 1: The scope of the above contracts does not cover roads within the Tsing Ma Control Area and Tsing Sha Control Area. The maintenance of the roads concerned is undertaken by the management, operation, and maintenance contracts managed by the Transport Department.

Note 2: The HyD conducts open tendering for road maintenance contracts in accordance with the established procedures. The cost of a road maintenance contract depends on a number of factors, including scope of maintenance, areas of roads, number of highway structures and other road facilities including roadside slopes, etc. under the contract. Traffic volume of roads within the contract area, maintenance frequency, and the equipment and machinery required for individual contracts (e.g. mechanical suction sweepers used in expressway maintenance contracts, etc.) will also affect the cost of the contract. Additionally, contractors will take into account factors such as prevailing wage levels, material costs, labour supply and market competitiveness in determining their tender prices of the maintenance works contracts when submitting tenders.
