

## Hong Kong International Airport (HKIA) - Partial Privatisation

As the consultation period on the proposed partial privatisation of HKIA draws to a close, I have been asked by HASPA members to make an additional submission.

The issue is related to the rights of the Airline Service Provider Community to carry out business activities:

a) at locations other than HKIA

b) of a nature other than for which (franchise) rights were granted (sole purpose).

Clearly, the Authority has an obligation to ensure its business partners and franchisees primary focus is to provide high quality aviation support services to enable the smooth running of the airport. This is fully understood.

However, the 'peak and trough' nature of airport activity has resulted in many of our members seeking opportunities to utilise the inevitable spare capacity available during less busy periods. Expensive assets, both people and equipment, could be much better utilised if the current restrictions were removed.

In summary, we would strongly support a change in Ordinance and/or franchise renewal terms to enable any company, based on the airport, to freely trade with any organisation, regardless of location.

In addition, we would ask that business partners and franchisees are allowed to conduct business activities outside the scope of 'required or optional services' provided, of course, they do not conflict with other core franchisee activity.

You will, no doubt, be aware that the Airport Authority itself has recently expanded its scope of business beyond HKIA.

We view it as extremely unfair, indeed unacceptable, for the Authority to impose restrictions on its business partners trading ability whilst, at the same time, expanding its own portfolio.

We welcome this opportunity to comment and would be very happy to elaborate if required.
