## ROAD WORKS UNDER PWP ITEM NO. 7870CL SITE FORMATION AND INFRASTRUCTURE WORKS FOR PUBLIC HOUSING DEVELOPMENT AT NGAU CHI WAN VILLAGE, WONG TAI SIN

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plans Nos. 60688473/GAZ/101 to 60688473/GAZ/102 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of a carriageway and footpaths;
- (ii) permanent closure and conversion of sections of the existing carriageways into footpaths;
- (iii) permanent closure and conversion of sections of the existing footpaths into carriageways and central reserve;
- (iv) permanent closure and conversion of a section of the existing central reserve into carriageway;
- (v) permanent closure and conversion of sections of the existing amenity areas into carriageways;
- (vi) temporary closure and reconstruction of sections of the existing carriageways and footpaths; and
- (vii) ancillary works including drainage, lighting, utilities, landscape and associated traffic aids and street furniture.
