

## **Roads (Works, Use and Compensation) Ordinance (Chapter 370)**

**Scheme annexed to Plan No. 5208968-GAZ-2003  
under section 5 describing**

**PWP Item No. B850CL**

**Site Formation and Infrastructure Works for  
Public Housing Development at Choi Shun Street, Sheung Shui**

### General Description of the Works

Under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) (“the Ordinance”), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plan No. 5208968-GAZ-2003 (“the Plan”) annexed hereto and described hereunder. The proposed road works are required for providing infrastructure necessary to support the public housing and school development at Choi Shun Street, Sheung Shui.

2. The general nature of the proposed works is as follows –
  - (i) construction of carriageways, footpaths, pedestrian crossings, traffic islands and a lay-by;
  - (ii) permanent closure and conversion of sections of the existing carriageways into footpaths, covered footpath, amenity areas, traffic islands and vehicular run-in/run-out;

- (iii) permanent closure and conversion of sections of the existing footpaths into carriageways, covered footpaths, amenity areas, pedestrian crossings and vehicular run-in/run-out;
- (iv) permanent closure and conversion of sections of the existing pedestrian crossings into carriageway and footpaths;
- (v) permanent closure and conversion of the existing traffic islands into carriageway;
- (vi) permanent closure and demolition of sections of the existing carriageway, footpaths and traffic island;
- (vii) temporary closure and reconstruction of sections of the existing carriageways and footpaths; and
- (viii) ancillary works including drainage, sewerage, waterworks, road marking, public lighting, landscaping, utility works and installation of street furniture and traffic aids.

### Roads to be Closed

3. For the purposes of or incidental to the works or the use, the Permanent Secretary for Transport and Logistics proposes that powers under section 17 of the Ordinance may be exercised to close permanently sections of the existing carriageways, footpaths, pedestrian crossings and traffic islands; and temporarily sections of the existing carriageways, footpaths, pedestrian crossings, traffic islands and lay-bys within the limit of works area as shown on the Plan. Temporary alternative access will be provided and temporary diversions will be carried out during the construction period as and when required. Further notice, setting out the manner in which such carriageways, footpaths, pedestrian

crossings, traffic islands and lay-bys are to be closed, will be issued under section 18 of the Ordinance as and when required.

Apparatus whose Course or Position to be Altered

4. For the purposes of or incidental to the works or the use, the Permanent Secretary for Transport and Logistics proposes that powers under section 20 of the Ordinance may be exercised to require alteration of the course or position of any gas, electricity, water or telecommunications service apparatus, such as electricity cables and ducts, telecommunication cables and ducts, water mains, stormwater drains, gas pipes and any other service apparatus lying within the limit of works area, and to require repairing of any road surface thereby disturbed. Further notice, setting out the manner in which the course or position of such apparatus is to be altered and such road surface is to be repaired, will be issued under section 20 of the Ordinance as and when required.
