Roads (Works, Use and Compensation) Ordinance (Chapter 370)

Scheme annexed to Plan No. 91853/TH/GAZ/0001 under section 5 describing

PWP Category D Item Lift and Pedestrian Walkway System between Lau Sin Street and Tin Hau Temple Road

General Description of the Works

Under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ("the Ordinance"), the Acting Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plan No. 91853/TH/GAZ/0001 ("the Plan") annexed hereto and described hereunder. The proposed road works are required to provide a convenient and comfortable pedestrian link between Tin Hau Temple Road and MTR Tin Hau Station as well as the public transport interchange at King's Road, and to serve as a safe and barrier-free access for the elderly and the disabled.

- 2. The general nature of the proposed works is as follows:
 - (i) construction of an elevated covered walkway;
 - (ii) permanent closure and conversion of a section of the existing footpath into a lift tower with associated lift; and
 - (iii) ancillary works including geotechnical, drainage, utilities, public lighting, landscaping, electrical and mechanical works and modification of the existing retaining wall including its parapet wall.

Roads to be Closed

3. For the purposes of or incidental to the works or the use, the Acting Permanent Secretary for Transport and Logistics proposes that powers under section 17 of the Ordinance may be exercised to close permanently a section of the existing footpath; and to close temporarily sections of the existing carriageways, footpaths and staircase within the limit of works area as shown on the Plan. Temporary alternative access will be provided and temporary diversions will be carried out during the construction period as and when required. Further notice, setting out the manner in which such carriageways, footpaths and staircase are to be closed, will be issued under section 18 of the Ordinance as and when required.

Apparatus whose Course or Position to be Altered

4. For the purposes of or incidental to the works or the use, the Acting Permanent Secretary for Transport and Logistics proposes that powers under section 20 of the Ordinance may be exercised to require alteration of the course or position of any gas, electricity, water or telecommunications service apparatus, such as electricity cables and ducts, telecommunication cables and ducts, water mains, drainage pipes, gas pipes and any other apparatus lying within the limit of works area and to require repairing of any road surface thereby disturbed. Further notice, setting out the manner in which the course or position of such apparatus is to be altered and such road surface is to be repaired, will be issued under section 20 of the Ordinance as and when required.
