TUEN MUN SOUTH EXTENSION

AUTHORIZATION FOR TEMPORARY CLOSURE AND ALTERATION OF WU KING ROAD AND ITS ADJACENT RAMP; TEMPORARY CLOSURE OF AN ACCESS ROAD CONNECTING WU SHAN ROAD AND FISH MARKETING ORGANIZATION CASTLE PEAK WHOLESALE FISH MARKET, AND SECTIONS OF A FOOTPATH ADJACENT TO TUEN MUN TYPHOON SHELTER, WU SHAN ROAD, WU CHUI ROAD AND A FOOTPATH NEAR WU SHAN RECREATION PLAYGROUND; AND TEMPORARY ALTERATION OF A SECTION OF A ROAD NEAR WU SHAN RECREATION PLAYGROUND

In exercise of the powers delegated by the Secretary for Transport and Logistics, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:-

- (I) the temporary closure and alteration of Wu King Road and its adjacent ramp, as delineated and shown in red on the Plans numbered TMSE/G05/0004/3 and TMSE/G06/0004/3, with details as follows:
 - (a) from 12:00 a.m. to 5:00 a.m. on 33 to 46 days during the period from 20 October 2025 to 19 October 2026, with all carriageway, parts of the footpath and its adjacent ramp widths temporarily closed; and
 - (b) during the period from 20 October 2025 to 19 October 2026, except the period specified in (I)(a) above, with the carriageway and its adjacent ramp temporarily altered, and parts of the footpath widths temporarily closed;
- (II) the temporary partial closure of the access road connecting Wu Shan Road and Fish Marketing Organization Castle Peak Wholesale Fish Market, as delineated and shown in pink on the Plan numbered TMSE/G05/0004/3;
- (III) the temporary partial closure of the section of the footpath adjacent to Tuen Mun Typhoon Shelter, as delineated and shown in purple on the Plan numbered TMSE/G05/0004/3;
- (IV) the temporary closure of the section of Wu Shan Road between a point about 210 metres west of its junction with Wu King Road and a point about 85 metres southeast of the junction, as delineated and shown in brown on the Plan numbered TMSE/G05/0004/3, with details as follows:

- (a) from 12:00 a.m. to 5:00 a.m. on 12 to 16 days during the period from 20 October 2025 to 19 October 2026, with all carriageway and parts of the footpath widths temporarily closed; and
- (b) during the period from 20 October 2025 to 19 October 2026, except the period specified in (IV)(a) above, with parts of the carriageway and the footpath widths temporarily closed;
- (V) the temporary partial closure of the section of Wu Shan Road between a point about 85 metres southeast of its junction with Wu King Road and a point about 510 metres southeast of the junction, as delineated and shown in blue on the Plans numbered TMSE/G05/0004/3, TMSE/G06/0004/3 and TMSE/G07/0004/3;
- (VI) the temporary partial closure of the section of Wu Chui Road between a point about 210 metres west of its junction with Wu King Road and a point about 310 metres east of the junction, as delineated and shown in orange on the Plan numbered TMSE/G06/0004/3;
- (VII) the temporary closure of the section of the footpath near Wu Shan Recreation Playground, as delineated and shown in yellow on the Plan numbered TMSE/G05/0004/3, with details as follows:
 - (a) from 12:00 a.m. to 5:00 a.m. on 4 to 9 days during the period from 20 October 2025 to 19 October 2026, with all the footpath widths temporarily closed; and
 - (b) during the period from 20 October 2025 to 19 October 2026, except the period specified in (VII)(a) above, with parts of the footpath widths temporarily closed; and
- (VIII) the temporary alteration of the section of the road near Wu Shan Recreation Playground, as delineated and shown in green on the Plan numbered TMSE/G05/0004/3,

during the period from 20 October 2025 to 19 October 2026. I further declare under section 22(1)(c) that during the period from 20 October 2025 to 19 October 2026, all public or private rights in, upon, under or over the sections of the roads, the footpaths and the ramp as described above shall be extinguished, modified or restricted, as the case may be.
