

RAILWAYS ORDINANCE (Chapter 519)
(Order under section 22(1))

SHATIN TO CENTRAL LINK

**AUTHORIZATION FOR
TEMPORARY CLOSURE OF HANG WAN ROAD, AND
SECTIONS OF SUNG WONG TOI ROAD,
OLYMPIC AVENUE AND DAKOTA DRIVE**

In exercise of the powers delegated by the Secretary for Transport and Logistics, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:-

- (I) the temporary partial closure of Hang Wan Road, as delineated and shown in dark blue on the Plans numbered SCL/G19/0071/1 and SCL/G22/0071/1 during the period from 6 September to 30 November 2024;
- (II) the temporary partial closure of the section of Sung Wong Toi Road between Ma Tau Chung Road and a point about 85 metres southeast of its junction with Pak Tai Street, as delineated and shown in brown on the Plans numbered SCL/G19/0071/1 and SCL/G22/0071/1 during the period from 6 September to 30 November 2024;
- (III) the temporary closure of the section of Olympic Avenue between its junction with Sung Wong Toi Road and a point about 80 metres northeast of the junction, and the section of Sung Wong Toi Road between Olympic Avenue and its junction with Kowloon City Road, as delineated and shown in green and red respectively on the Plans numbered SCL/G19/0071/1 and SCL/G22/0071/1, with details as follows:
 - (a) from 11:00 p.m. to 6:00 a.m. of the following day on 2 to 4 days during the period from 6 September to 30 November 2024, with all carriageway and footpath widths of the sections of the roads temporarily closed; and
 - (b) during the period from 6 September to 30 November 2024, except the period specified in (III)(a) above, with parts of the carriageway and footpath widths of the sections of the roads temporarily closed; and
- (IV) the temporary closure of the section of Olympic Avenue between a point about 80 metres northeast of its junction with Sung Wong Toi Road and its junction with Dakota Drive, and the section of Dakota Drive between its junction with Olympic Avenue and a point about 30 metres southeast of the junction, as delineated and shown in purple and light blue respectively on the Plan numbered SCL/G19/0071/1, from 11:00 p.m. to 6:00 a.m. of the following day on 2 to 4 days during the period from 6 September to 30 November 2024.

I further declare under section 22(1)(c) that during the period from 6 September to 30 November 2024, all public or private rights in, upon, under or over the sections of the roads as described above shall be extinguished, modified or restricted, as the case may be.
