RAILWAYS ORDINANCE (Chapter 519) (Order under section 22(1))

SHATIN TO CENTRAL LINK

AUTHORIZATION FOR TEMPORARY CLOSURE AND ALTERATION OF SECTIONS OF SUNG WONG TOI ROAD; AND TEMPORARY CLOSURE OF HANG WAN ROAD, AND SECTIONS OF OLYMPIC AVENUE, DAKOTA DRIVE AND PAK TAI STREET

In exercise of the powers delegated by the Secretary for Transport and Logistics, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:-

- (I) the temporary closure and alteration of the section of Sung Wong Toi Road between Ma Tau Chung Road and a point about 55 metres southeast of its junction with Kowloon City Road, as delineated and shown in brown on the Plans numbered SCL/G19/0073/1 and SCL/G22/0073/1, with details as follows:
 - (a) from 11:00 p.m. to 6:00 a.m. of the following day on 1 to 2 days during the period from 1 June to 31 December 2025, with the carriageway temporarily altered and all footpath widths temporarily closed; and
 - (b) during the period from 1 April 2025 to 31 March 2026, except the period specified in (I)(a) above, with parts of the carriageway and footpath widths temporarily closed;
- (II) the temporary closure of the section of Sung Wong Toi Road between Olympic Avenue and its junction with Kowloon City Road, and the section of Olympic Avenue between its junction with Sung Wong Toi Road and a point about 80 metres northeast of the junction, as delineated and shown in red and green respectively on the Plans numbered SCL/G19/0073/1 and SCL/G22/0073/1, with details as follows:
 - (a) from 11:00 p.m. to 6:00 a.m. of the following day on 1 to 2 days during the period from 1 June to 31 December 2025, with all carriageway and footpath widths temporarily closed; and
 - (b) during the period from 1 April 2025 to 31 March 2026, except the period specified in (II)(a) above, with parts of the carriageway and footpath widths temporarily closed;
- (III) the temporary partial closure of Hang Wan Road, as delineated and shown in dark blue on the Plans numbered SCL/G19/0073/1 and SCL/G22/0073/1 during the period from 1 April 2025 to 31 March 2026;

- (IV) the temporary closure of the section of Olympic Avenue between a point about 80 metres northeast of its junction with Sung Wong Toi Road and its junction with Dakota Drive, and the section of Dakota Drive between its junction with Olympic Avenue and a point about 30 metres southeast of the junction, as delineated and shown in purple and light blue respectively on the Plan numbered SCL/G19/0073/1, from 11:00 p.m. to 6:00 a.m. of the following day on 1 to 2 days during the period from 1 June to 31 December 2025; and
- (V) the temporary partial closure of the section of Pak Tai Street between its junction with Sung Wong Toi Road and a point about 90 metres southwest of the junction, and the section of Sung Wong Toi Road near its junction with Pak Tai Street, as delineated and shown in yellow and orange respectively on the Plans numbered SCL/G19/0073/1 and SCL/G22/0073/1 during the period from 15 May 2025 to 31 March 2026.

I further declare under section 22(1)(c) that all public or private rights in, upon, under or over (i) the sections of the roads as described in (I) to (IV) above during the period from 1 April 2025 to 31 March 2026; and (ii) the sections of roads as described in (V) above during the period from 15 May 2025 to 31 March 2026, shall be extinguished, modified or restricted, as the case may be.
