

**RAILWAYS ORDINANCE (Chapter 519)**  
**(Order under section 22(1))**

**TUNG CHUNG LINE EXTENSION**

**AUTHORIZATION FOR  
TEMPORARY CLOSURE OF SECTIONS OF  
SHUN TUNG ROAD, TAT TUNG ROAD, YI TUNG ROAD,  
TUNG CHUNG WATERFRONT ROAD AND YING HEI ROAD, AND  
PART OF THE OPEN SPACE BETWEEN  
PHASE 1 AND PHASE 2 OF TUNG CHUNG CRESCENT**

In exercise of the powers delegated by the Secretary for Transport and Logistics, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:—

- (I) the temporary partial closure of the section of Shun Tung Road between a point about 45 metres south of its junction with Tung Chung Waterfront Road and a point about 650 metres southeast of the junction, as delineated and shown in yellow on the Plan numbered TCLE/G03/0001/4;
- (II) the temporary partial closure of the section of Tat Tung Road between its junction with Shun Tung Road and a point about 60 metres northeast of the junction (near Tung Chung Swimming Pool), as delineated and shown in orange on the Plan numbered TCLE/G03/0001/4;
- (III) the temporary partial closure of the section of Tat Tung Road between its junction with Shun Tung Road and a point about 50 metres northeast of the junction (near Fu Tung Estate), as delineated and shown in purple on the Plan numbered TCLE/G03/0001/4;
- (IV) the temporary closure of part of the open space between Phase 1 and Phase 2 of Tung Chung Crescent, as delineated and shown in red on the Plan numbered TCLE/G03/0001/4;
- (V) the temporary partial closure of the section of Yi Tung Road between a point about 85 metres north of its junction with Tung Chung Waterfront Road and a point about 60 metres south of the junction, as delineated and shown in green on the Plan numbered TCLE/G06/0001/4; and
- (VI) the temporary partial closure of the section of Tung Chung Waterfront Road between its junction with Yi Tung Road and a point about 50 metres west of the junction, and the section of Ying Hei Road between its junction with Yi Tung Road and a point about 50 metres east of the junction, as delineated and shown in blue and pink respectively on the Plan numbered TCLE/G06/0001/4,

during the period from 12 May 2026 to 11 May 2027. I further declare under section 22(1)(c) that during the period from 12 May 2026 to 11 May 2027, all public or private rights in, upon, under or over the sections of the roads and the part of the open space as described above shall be extinguished, modified or restricted, as the case may be.
