AND FANLING NORTH NEW DEVELOPMENT AREA
KWU TUNG NORTH NEW DEVELOPMENT AREA
(ROAD WORKS)

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plans Nos. 60624717/GAZ/1000 to 60624717/GAZ/1009 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of at-grade carriageways, an elevated carriageway, at-grade footpaths, elevated footpaths, at-grade cycle tracks, an elevated cycle track, footbridges, cycle parking areas, at-grade central reserves/refuge islands, at-grade amenity areas, run-ins/ run-outs, at-grade pedestrian crossings, elevated pedestrian crossings, staircases, lifts, vertical noise barriers, cantilever noise barriers, slopes and retaining walls;
- (ii) permanent closure and conversion of sections of the existing at-grade carriageways into at-grade footpaths, at-grade cycle tracks, a cycle parking area, at-grade central reserves/refuge islands, at-grade amenity areas, run-ins/run-outs and at-grade pedestrian crossings;
- (iii) permanent closure and conversion of sections of the existing at-grade footpaths into at-grade carriageways, at-grade cycle tracks, at-grade central reserves/refuge islands and at-grade amenity areas;
- (iv) permanent closure and demolition of sections of the existing at-grade carriageways and at-grade footpaths;
- (v) temporary closure and modification of sections of the existing at-grade carriageways and at-grade footpaths; and
- (vi) ancillary works including geotechnical, slope stabilization, drainage, sewerage, water, utilities and landscaping works.

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Logistics not later than the 29th day of November 2022.

Any information, including the personal data, submitted to the Secretary for Transport and Logistics in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
