## PWP ITEM NO. 6876TH IMPROVEMENT OF LION ROCK TUNNEL

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plans Nos. 60604728/R61/100 to 60604728/R61/108 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of a three-lane tunnel tube of approximately 1.4 kilometres (km) long between the two existing tunnel tubes of the Lion Rock Tunnel with associated pedestrian cross passages linking with (ii);
- (ii) widening of the existing southbound tunnel tube of the Lion Rock Tunnel from a two-lane tunnel tube to a three-lane tunnel tube:
- (iii) rehabilitation of the existing northbound tunnel tube of the Lion Rock Tunnel;
- (iv) modification of the existing toll plaza of the Lion Rock Tunnel at Sha Tin;
- (v) construction of an elevated carriageway across Lion Rock Tunnel Road at the toll plaza at Sha Tin to serve tunnel operations;
- (vi) construction of a footbridge with lifts across Lion Rock Tunnel Road at the toll plaza at Sha Tin;
- (vii) widening of sections of the existing Lion Rock Tunnel Road between Sha Tin Road and Waterloo Road;
- (viii) modification of the slip roads connecting Lung Cheung Road eastbound with Lion Rock Tunnel Road:
- (ix) modification of the slip roads connecting Hung Mui Kuk Road with Lion Rock Tunnel Road:
- (x) construction of tunnels, pedestrian cross passages, at-grade carriageways, elevated carriageways, footbridge and associated staircases, footpaths/staircases, lifts, amenity areas, central reserves/refuge islands, pedestrian crossings, verges and parking areas;
- (xi) permanent closure and demolition of sections of the existing tunnel, at-grade carriageways, footbridges and associated staircases, footpaths/staircases, amenity areas, central reserves/ refuge islands, pedestrian crossings;
- (xii) demolition of sections of the existing buildings/structures;
- (xiii) temporary closure and rehabilitation of the existing tunnel;
- (xiv) temporary closure and reconstruction of sections of the existing tunnel, at-grade carriageways, footbridge and associated staircases, footpaths/staircases, amenity areas and central reserves/refuge islands; and
- (xv) ancillary works including geotechnical, slope, drainage, sewerage, water, utilities, lighting, landscaping, electrical and mechanical, and building works; installation of street furniture as well as traffic aids; construction of semi-enclosure noise barriers, vertical noise barriers with cantilever, buildings/structures for tunnel operations, retaining walls and slopes.
