2. By signing of this Deed of Undertaking, the Company understands that it is bound by the terms and conditions of this Deed of Undertaking and those contained in or in connection with the captioned Scheme; that the Company has entered into a contractual relationship with the Government and the trainee respectively. The Company shall bear liability whatsoever in the event of a breach of this Deed of Undertaking by itself or in the event of a breach of the Deed of Undertaking given by the trainee(s). I have read and fully understand the terms set out in this Deed of Undertaking and the Company shall forthwith refund in full the value of the Sponsorship received by the Company to the Government within one (1) calendar month upon receipt of the Government's written request if the Company is in

breach of any of the undertakings set out in this Deed of Undertaking. If an exceptional circumstance exists and leads to the breach of any undertakings, the Company shall inform the Government of such circumstances in writing immediately. The Government will decide whether to grant any waiver to the relevant terms and conditions of this Deed of Undertaking. The Company understands that the Government has the absolute discretion of whether to grant such waiver and the Company agrees and undertakes that the Company shall not raise any claim, complaint or objection against the Government for whatever decision it makes.

- 3. The Company also consent the Government to use any information related to the Company for activities / publications / matters related to the handling of the Sponsorship and/or the training programme under the Sponsorship and the enforcement of this Deed of Undertaking. The Company acknowledge that it has been recommended to seek independent legal advice on this Deed of Undertaking.
- 4. Each of the provisions of this Deed of Undertaking is severable and distinct from the others and, if one or more of such provisions or any part thereof is or becomes illegal, invalid or unenforceable, the legality and enforceability of the remainder of this Deed of Undertaking shall not be affected or impaired in any way.
- 5. This Deed of Undertaking shall be governed by and construed in accordance with the laws of Hong Kong. The Company hereby agrees to first refer any dispute or difference arising out of or in connection with the Deed of Undertaking to mediation in accordance with The Government of the Hong Kong Special Administrative Region Mediation Rules prevailing at the time. If the said dispute or difference is not settled by mediation, a party may institute litigation in respect of the said dispute or difference. The Company agrees that the courts of Hong Kong shall have exclusive jurisdiction in respect of the said dispute or difference.
