一般須知 General information

「海運和航空業實習計劃(航空)」(實習計劃)旨在為年輕一代提供實習機會,並且提供資助,讓他們及早了解海運業的運作和就業前景。

The objective of the Maritime and Aviation Internship Scheme (Aviation) (Internship Scheme) is to provide the young generation with the internship experience and sponsorship so as to give them early exposures to the operations and career prospects in the maritime industry.

2. 獲參與公司聘用的合資格申請人,將會進行為期四星期(即 28 天)或以上的實習,期間可獲該公司支付酬金(部分由海運及空運人才培訓基金資助)。

An eligible applicant employed by a participating company will be engaged in internship for four weeks (i.e. 28 days) or more, and receive an honorarium from the company (part of which is sponsored by the MATF).

符合資格的申請人 Eligible applicants

- 3. 申請人必須為可在**香港合法受僱之香港居民**,並同時是¹-
 - (a) 於**本地院校**²修讀任何學士學位或副學位課程的**本地**全日制**學生**³(包括準畢業生);或
 - (b) 於**香港以外院校**修讀任何學士學位或副學位課程的全日制學生(包括準畢業生);或
 - (c) 中六離校生。

An applicant must be a **Hong Kong resident** who is **lawfully employable in Hong Kong** and currently⁴ –

- (a) a full-time **local** student⁵ (including one who is in his/her final year of study) undertaking an undergraduate or sub-degree programme in any **local institution**⁶; or
- (b) a full-time student (including one who is in his/her final year of study) undertaking an undergraduate or sub-degree programme in any **institutions outside Hong Kong**; or
- (c) a secondary six school leaver.

5. 申請人必須在有關實習職位的截止日期前,填妥本申請表,連同履歷表<u>直接遞交予相關公司</u>。各實習職 位的申請截止日期或有所不同,逾時的申請可能不獲相關公司考慮。

An applicant should complete and submit this application form, together with curriculum vitae, <u>directly to</u> the company concerned by the deadline specified for the internship position of choice. Please note that the deadlines for different internship positions may vary, and late applications may not be considered by the companies concerned.

6. 申請人必須填妥本申請表上的所有部份,並在申請表上簽署。申請人如未能提供所需的所有資料,申請可能不獲相關公司考慮。

An applicant should complete all parts of this application form, and sign the form as required. Incomplete application forms may not be considered by the companies.

- 7. 在有需要時,申請人會被要求核實所提交的資料及/或提供補充資料,以便進一步處理有關申請。 An applicant may be required to verify the information submitted and/or to provide additional information for further processing of his/her application.
- 8. 申請人向有關公司提供個人資料,屬於自願性質。該公司在處理你提交的申請期間收集的所有個人資料,只用於直接與該申請相關的用途。

An applicant provides his/her personal data to the relevant company on a voluntary basis. All personal data collected by the company concerned during the application process shall be used only for the purposes directly related to the applications.

9. 如申請人獲成功聘用,僱主會將他/她的申請資料送交相關政府部門及其他組織或機構作處理及檢討實習計劃和基金的成效之用。

If an applicant is successfully employed by a company, the information given in his/her application will be provided by the company to the relevant Government departments and other organisations or agencies for further processing and review of the effectiveness of the Internship Scheme and the MATF.

- 10. 如欲查詢或要求更正申請表上的個人資料,可以書面方式向有關公司提出。
 Enquiries in relation to or requests for correction of the personal data provided in application forms can be raised to the companies concerned in writing.
- 11. 申請人在實習期滿後 14 天內須填妥並向相關公司提交由運輸及物流局提供的實習生評估報告表。
 An applicant should, within 14 days after the completion of internship, complete and submit the "Evaluation Form for Interns" provided by the Transport and Logistics Bureau to the company concerned.
