Maritime and Aviation Training Fund Professional Training and Examination Refund Scheme (Aviation) Application Form

申請人須知 Notes for Applicants

一般須知 General Information

1. 「專業培訓課程及考試費用發還計劃」(「計劃」)旨在鼓勵有志投身航空業的人士和現職人士,修讀由各院校、專業或業界團體提供的課程和參加專業考試,以提升技能及獲得專業資格。計劃下的成功申請人在完成經核准的課程或通過相關專業考試後,可獲發還80%的費用。

The objective of the Professional Training and Examination Refund Scheme (the "Scheme") is to incentivise those interested to join, as well as already working in, the aviation sector, to attend course(s) and sit for examinations(s) that are being offered by various education institutions, professional or trade bodies to raise their professionalism and competency, and encourage them to acquire relevant professional qualification(s). Under the Scheme, successful applicants will be refunded 80% of the fees for completing pre-approved course(s)/examination(s).

2. 經核准的課程/考試名單會適時作出檢討。有關經核准的課程/考試名單的資料,請瀏覽基金的網頁 (http://www.matf.gov.hk)。

The list of approved courses/examinations will be updated from time to time. For more information on the pre-approved courses/examinations, please refer to MATF's website http://www.matf.gov.hk.

符合資格的申請人 Persons who are eligible to apply

- 3. 申請必須以個人名義提出,並不接受公司/團體的申請。就每項申請:
 - (a) 申請人必須 -
 - (i) 為香港居民及可在香港合法受僱;
 - (ii) 在提出本申請時,受聘於在香港營運的組織/公司及全職從事與航空有關的工作;
 - (b) 申請人修讀或參加任何一個經核准的課程或考試,並**成功達到舉辦課程機構的要求**或**通過考試**;及
 - (c) 申請人必須**從未**就同一項課程/考試獲任何其他補助或資助。

Applications must be made by **individuals**. Applications from company/organisation will not be accepted. For each application,

- (a) the applicant must:
 - (i) be a Hong Kong resident and lawfully employable in Hong Kong;
 - (ii) be in full-time employment in the aviation sector with an organisation/company in Hong Kong at the time of application;
- (b) the applicant has enrolled in or taken one of the pre-approved courses or examinations, and has **completed the course to the satisfaction of the course provider or passed the examination**; and
- (c) the applicant has **NOT** been granted any other forms of subsidy or financial assistance for the relevant preapproved course(s)/examination(s).

形式、金額及款項發放安排 Format, Level of Support and Payment Method

4. 每名成功申請人可獲發還有關經核准課程/考試費用的80%或上限30,000港元(以數額較小者為準)。申請人只可獲發還已支付的經核准課程/考試的學費及考試費,任何其他費用,如註冊費、行政費、逾期罰款及更改課程/考試的費用等,均不會獲發還。

Each successful applicant will be refunded **80%** of their fees, **subject to a maximum of HK\$30,000**, (whichever is less) for the pre-approved course(s)/examination(s). Only the fees for enrolling in the pre-approved course(s) or taking pre-approved examination(s) can be refunded. Any other charges, such as registration fees, administration fees, late charges and change of course/examination fee charges are not eligible for refund.

- 5. 每名人士可就多於一項課程/考試申請發還費用,上限為每人**30,000港元**。
 Each individual may apply for fee refund for more than one pre-approved course/examination, **up to a ceiling of HK\$30,000 per person** under the Scheme.
- 6. 申請人申請費用發還的課程/考試必須於首次納入「已核准的課程/考試名單」的月份內或之後報讀/報考才符合申請資格。

The course/examination that the applicant applies for refund must be taken within or after the month of its first issue on the "Pre-approved Courses/Examinations List".

- 7. 除另有註明外,在「已核准的課程/考試名單」上所列的學費/考試費用以港元為單位。所列的費用只供參考, 有關機構可作相關調整而不作另行通知。如欲查詢最新的學費/考試費,請與有關機構聯絡。
 - Unless otherwise specified, the course/examination fees quoted on the "Pre-approved Courses/Examinations List" are in Hong Kong Dollars. The fees provided are for reference only. Course providers/examination authority(ies) may make adjustments without prior notice. For any enquires related to the latest course/examination fees, please contact the relevant course providers / examination authority(ies).
- 8. 在本計劃下,所有學費/考試費用發還以**港元**發放。如舉辦課程/考試的機構只接受以港元以外的貨幣繳交學費/考試費,運輸及物流局在計算可發放的退費金額時,會以香港銀行公會在課程/考試前一個4月1日所公佈的中間匯率(即貨幣賣出價和電匯買入價的中間數)折算為港元計算。在任何情況下,申請人不可就匯率差額向運輸及物流局提出索償。

All refund made under this Scheme will be in **Hong Kong Dollars**. If any other currency other than Hong Kong Dollars was the sole payment currency accepted by the course provider(s)/examination authority(ies) concerned, for the purpose of calculating the refund amount, TLB will convert the fee at the Hong Kong Association of Banks (HKAB) mid-market rate (i.e. mid-point between the opening selling and buying TT rates) on the 1 April preceding the course/examination. Under no circumstances can the applicant claim TLB for any exchange loss arising from exchange rate fluctuations.

- 9 費用會按先到先得方式發還,直至計劃已沒有可供運用的款項。 Refunds will be granted on a first-come-first-served basis, until all funding for the Scheme has been expended.
- 10. 發還的款項會直接存入成功申請人指定接收款項的銀行帳戶。
 Payment will be made to the successful applicant by direct credit to the bank account nominated by the applicant.

申請手續 Procedures for application

11. 申請人必須**於完成經核準課程/通過經核準考試後<u>四個月內</u>**提出申請。填妥的申請表須<u>郵寄至香港添美道2號政府總部東翼20樓運輸及物流局海運及空運人才培訓基金秘書處</u>或**電郵**至 matf@tlb.gov.hk。郵資不足的信件將不獲接收。逾時的申請將不獲受理。

Applicants must complete and submit the application form <u>within four months</u> after completing a pre-approved course / passing an pre-approved examination, whichever is applicable. Application forms must be submitted <u>by post</u> to the Maritime and Aviation Training Fund Secretariat, Transport and Logistics Bureau at 20/F, East Wing, Central Government Offices, 2 Tim Mei Avenue, Hong Kong; or <u>by email</u> to <u>matf@tlb.gov.hk</u>. Mail items bearing insufficient postage will be rejected. Late applications will not be accepted.

- 12. 運輸及物流局會於收到申請書後兩星期內將認收回條寄回給申請者。如申請者在兩星期內仍未收到回條,請發送電郵至 matf@tlb.gov.hk 或致電基金熱線 3509 7267 查詢。
 - Acknowledgement of receipt will be sent to an applicant within two weeks upon receipt of the application. If the acknowledgement is not received within two weeks, applicants should make enquiry by emailing to matf@tlb.gov.hk or call the MATF hotline at 3509 7267.
- 13. 申請人可用一份申請表提出一項或以上的課程/考試費用的申請。
 Applicants may complete one application form for one or more courses / examinations for refund.
- 14. 申請人必須填妥申請表上的A至F部,並在申請書上簽署。未滿18歲的申請人的父母或監護人亦須於申請書上簽署。申請人如未能提供全部所需的資料,申請將不獲受理。
 - Applicants should complete all parts of the application form (Sections A-F), and sign the application form as required. For applicants aged under 18, signature of their parent or guardian is required. Incomplete application forms will not be processed.

- 15. 申請人於遞交申請書時,應夾附下列文件的副本:
 - (a) 申請人的香港身份證(請參看第17段);
 - (b) 供發還款項的帳戶的銀行名稱、帳戶持有人的姓名及帳戶號碼的證明文件,例如存摺首頁/月結單首頁/ 提款卡(帳戶持有人的姓名必須與申請人的香港身份證上的姓名相同);
 - (c) 由舉辦課程/考試的相關機構發出,證明申請人已達到課程要求或通過考試的文件(如證書、成績單或信件);
 - (d) 由舉辦課程/考試的相關機構發出的學費/考試費的收據(收據上必須顯示申請人的姓名及課程/考試名稱);
 - (e) 由在香港營運的相關航空業組織/公司發出的申請人受聘證明文件(不接受僱傭合約、名片及員工證), 文件上須清楚顯示 -
 - (i) 僱主公司名稱及公司印章;
 - (ii) 申請人姓名(必須與香港身份證上的姓名相同)及香港身份證號碼;
 - (iii) 申請人全職受僱的時間,包括開始及結束日期(受僱日期必須涵蓋申請費用發還的日期);
 - (iv) 申請人全職受僱的職位及工作內容(須與航空有關的工作);
 - (v) 受僱公司的授權人士(如人力資源部職員或直屬上司)的簽署、姓名及職位;
 - (vi) 簽發日期(在申請日前一個月內發出的有效文件也可接受);及
 - (f) 課程/考試評估。

When submitting the application form, the applicant should attach a copy of each of the following -

- (a) the applicant's Hong Kong Identity Card (Please see paragraph 17);
- (b) document issued by the bank showing the number and name of holder of the bank account to which the refund will be credited to, such as the front page of bank passbook/statement of bank account/automatic teller machine card (name of the account holder must be the same as that in the applicant's Hong Kong Identity Card);
- (c) documentary proof(s) (e.g. certificate, transcript, letter) issued by the relevant course provider(s)/examination authority(ies) certifying that the applicant has completed the course to the satisfaction of the course provider or passed the relevant examination;
- (d) official payment receipt(s) of course/examination fee payment (with the name of applicant and the course(s)/examination(s) shown) issued by the relevant course provider(s)/examination authority(ies);
- (e) documentary proof(s) to certify the applicant's employment issued by a relevant organisation/company of the aviation sector in Hong Kong (employment contract, business card and staff card are not accepted), the proof(s) must contain the following information
 - (i) Name of applicant's company and company stamp;
 - (ii) Applicant's name (same as that shown on HKID card) and HKID number;
 - (iii) Applicant's full-time employment period (including the start day and last day of work, the period must cover the date of application);
 - (iv) Applicant's full-time job title and job duties (must be aviation-related)
 - (v) Company's aurthorised person's signature, and job title (e.g. staff of Human Resources Department or direct supervisor);
 - (vi) Issue date (valid document issued within the last month from the application date would also be accepted); and
- (f) Course/examination evaluation.
- 16. 在有需要時,運輸及物流局會要求申請人就所提交的資料作出解釋或提供補充資料,以便進一步處理有關申請。 申請人需保留所有已提交文件的正本(例如學費收據、課程修畢證明和考試成績單等)。

Applicants may be required to verify the information submitted and to provide additional information necessary for processing the applications further. Applicants should keep the original of the supporting documents submitted (e.g tuition fee receipts, proof of course completion, result slip of examination, etc.).

17. 所有已遞交的申請書及證明文件副本概不退還。申請人應**自備副本**,以作參考。申請人可選擇於辦公時間內親身 到香港添美道2號政府總部東翼20樓運輸及物流局海運及空運人才培訓基金秘書處,提供其香港身份證正本供職員 核實有關資料,代替提交香港身份證副本。

All documents submitted for the application (including the application form and the supporting documents) are not returnable. Applicants are advised to retain copies for their own reference. Applicants may choose to visit to the Maritime and Aviation Training Fund Secretariat, Transport and Logistics Bureau at 20/F, East Wing, Central Government Offices, 2 Tim Mei Avenue, Hong Kong, in person during normal office hour and produce their Hong Kong Identity Cards for checking, in lieu of submission of a copy of the Hong Kong Identity Card.

個人資料收集 Personal Data Collection

- 申請人有責任詳盡及真確地填妥申請書及提交所需文件。運輸及物流局會根據個人資料私隱專員所發出的《身分證 號碼及其他身分代號實務守則》,要求申請人提供其香港身份證副本。如申請人未能遵照上述要求,運輸及物流局 可能無法處理其申請。對於申請書上填報的個人資料,運輸及物流局將作下列用途:(a)關乎處理和覆查就海運及 空運人才培訓基金而提出的各種活動申請; (b) 關乎追討付款(如有的話)的各種活動;及 (c) 統計與研究用途。 Applicants are responsible for completing the application form fully and truthfully and providing all necessary documentary proof. In accordance with the Code of Practice on the Identity Card Number and Other Personal Identifiers issued by the Privacy Commissioner for Personal Data, applicants are requested to furnish a copy of their Hong Kong Identity Card. If an applicant fails to comply with these requirements, TLB may not be able to process his/her application. TLB will use the personal data provided in the applications for the purposes of (a) activities relating to the processing and counter-checking of an application under the MATF; (b) activities relating to the recovery of payments, if any; and (c) statistics and research.
- 19. 申請表上填報的個人資料以及其他補充資料,可為上文第18段所述的目的,或在法律授權及/或規定作出披露的情 況下,向特區政府的相關決策局/部門/組織,舉辦相關課程/考試的機構以及相關僱主披露。 The personal data and other supplementary information that are provided in the application may be disclosed to the relevant

Government policy bureau(x)/department(s)/organisation(s), the relevant course provider(s)/examination authority(ies) and the relevant employer(s) for the purposes mentioned in point 18 above or where such disclosure is authorised and/or required

by law.

20. 如有需要,運輸及物流局會為上文第18段所述的目的,聯絡舉辦相關課程/考試的機構、相關僱主及特區政府的相 關決策局/部門/組織,以核實申請書上的資料。

If necessary, TLB will contact the relevant course provider(s)/examination authority(ies), employer(s), and government policy bureau(x)/department(s)/organisation(s) to verify the data provided in the application with those held by them for the purposes mentioned in point 18 above.

21. 根據《個人資料(私隱)條例》(第486章)第18及22條以及附表1第6原則,申請人有權要求查閱和改正申請書上 的個人資料。

In accordance with sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance (Chapter 486 of the Laws of Hong Kong), applicants have the right to request access to and correction of the personal data supplied in their applications.


