GUIDANCE NOTES

Please read the following Notes before completing this application form.

General

1. The Sea-going Training Incentive Scheme aims to encourage Hong Kong youngsters to take on and complete sea-going training with a view to developing their future careers in the port and maritime support industries.
2. The incentive will be awarded to successful applicants on a first-come-first-served basis, subject to the availability of fund.
3. When the Scheme is over-subscribed, the date on which the application is received by the Marine Department will be used to determine eligibility.
4. Under the Scheme, a cadet will receive HK\$10,000 per month from the Government during the individual stipulated training period which will qualify him/her to sit for the Class 3 Deck/Engineer Officer Examination. The incentive will be paid in arrears directly to the successful applicants by the Marine Department as a lump sum on completion of each employment contract up to the maximum training period of 18 months for Deck Cadet and 12 months for Engineer Cadet. Completion of each employment contract has to be certified by the employer. The cadet may also apply for the reimbursement of first examination fee after passing the examination.
5. Applicants who are serving cadets at the time of application may have already completed part of the stipulated training period, then, only those actual sea-going training which started after the date of receipt of the application by the Marine Department may be considered valid for incentive.
6. If the sea-going training contract was not drawn up in terms of complete months, the subsidy should be paid on pro-rata basis.
7. No payment of the incentive or any part thereof will be made to sea service of an uncompleted employment contract unless the uncompleted contract is terminated by mutual agreement between the company and the cadet.
8. The form should be completed in BLOCK LETTERS.
9. Together with copies of all supporting documents, application may be submitted in person or by post, fax (fax no. 2545 4669) or e-mail (sssem@mardep.gov.hk, mmd@mmd.gov.hk) to the Seagoing Examination and Mercantile Marine Office, Marine Department (Room 302, 3/F, Harbour Building, 38 Pier Road, Central, Hong Kong) for approval before the commencement of his/her sea-going training. Originals of documents should be produced to the Seagoing Examination and Mercantile Marine Office, Marine Department within 14 working days from the date of application. Applicants who are serving cadets at sea at the time of application are allowed to submit the originals of documents within 14 working days from the date of completion of the employment contract or the date of return Hong Kong.
10. Please enclose a stamped self-addressed envelope for receiving the result of your application.

Eligibility Criteria

11. The applicant must be a Hong Kong permanent resident.
12. The applicant must be a graduate from a maritime training institute (or equivalent institute) recognized by the Marine Department and his/her qualification acquired should be of a level qualified him/her to sit for the Class 3 Deck or Engineer Officer Examination held by the Marine Department.
13. Final year student of a recognized maritime training programme may also apply if he/she has already obtained an offer of employment for sea-going training by the time of submitting the application.
14. The applicant must be registered as a seafarer with the Marine Department.
15. The applicant must not have been granted double benefits i.e. other kind of financial assistance granted for the purpose of encouraging graduates from

一般事項

1. 航海訓練獎勵計劃旨在鼓勵香港青少年接受及完成航海訓練，以發展他們未來在港口及海事支援行業的事業。
 2. 視乎撥款情況，獎勵金將以先到先得的方式發放給成功的申請人。
 3. 當該計劃收到超額申請時，將以海事處收到申請的日期先後決定資格。
 4. 計劃下，實習生在就其本人規定的通過實習而取得應考甲板高級船員三級/輪機師三級資格的受訓期內可獲得政府資助每月 10,000 元。海事處會於每份僱用協議完成之後直接把獎勵金一筆過付給獲批核的申請人，甲板實習生和輪機實習生的資助培訓期最長分別為 18 個月和 12 個月。每份僱用協議的完成須由僱主證明確認。實習生亦可在通過考試後向海事處申請退還第一次考試費用。
 5. 屬在職實習生的申請人於申請時可能已完成部分的規定受訓期，就此，可能只有在海事處收到申請當日之後展開的實際航海訓練期才符合發放獎勵的資格。
 6. 如航海受訓期並非整月，資助將按比例支付。
 7. 除非船舶公司及實習生雙方同意終止未完成的僱用協議，否則未完成的僱用協議的海上服務資歷不會獲得發放獎勵金或部分獎勵金。
 8. 本表格應以大楷填寫。
 9. 申請人可親身或以郵寄、傳真(2545 4669)或電郵 (sssem@mardep.gov.hk, mmd@mmd.gov.hk) 方式一併遞交申請表和所有證明文件副本至海事處遠洋航行考試及商船海員管理處（香港中環統一碼頭道 38 號海港政府大樓 3 樓 302 室）批核。文件正本應在申請日起計 14 個工作天內交給遠洋航行考試及商船海員管理處查核。如申請人在申請之時為在職海上實習生，則可於僱用協議完成後或返回香港後 14 個工作天內遞交文件正本。
 10. 申請人須附上已付郵資的回郵信封，以便收取申請結果。

11. 申請人必須為香港永久性居民。
 12. 申請人必須畢業於香港海事處所承認之海事訓練學院(或等等的學院)，並且符合資格參加由海事處舉辦的甲板高級船員三級/輪機師三級考試。
 13. 認可海事訓練課程的應屆畢業生若在遞交申請日期之前已獲聘進行航海訓練，也可提出申請。
 14. 申請人必須為香港海事處之註冊海員。
 15. 申請人不得獲批雙重福利，即不得就同一航海訓練期獲批用以鼓勵認可海事訓練院校畢業生接受航海實習生訓練的其他類別的資助。

16. Qualifying sea services must be performed as cadet in either deck or engine department in accordance with his/her discipline.
17. Sea service is to be verified by proper entries in both the crew agreements and the official discharges from the ships or the record of employment registration book. In the case of service performed in ships that are foreign ships, written confirmation by a Consul or some other recognized official of the country of registry is acceptable.
18. Sea service as entered in official discharges and testimonials will be reckoned by the calendar months, that is, the time included between any given day in any month and the preceding day of the following month, both inclusive. The number of complete months from the commencement of the period, ascertained in this way, should be computed, after which the number of odd days should be counted. The day of which the crew agreement commences, as well as that on which it terminates, should both be included, all leave of absence excluded and all odd days added together and reckoned at thirty days to the month. The followings are examples:
