- I promise that I will sit for all or any one exam paper(s) of the Deck Officer Class 3 / Marine Engineer Officer Class 3 Certificate of Competency Examination within 12 months from the Return Date filled in Part C of this application form.  - the continued payment of subsidy to the Applicant is contrary to the interest of national security; or

General

1. The Sea-going Training Incentive Scheme aims to encourage Hong Kong youngsters to take on and complete sea-going training with a view to developing their future careers in the port and maritime support industries.
2. The incentive will be awarded to successful applicants on a first-come-first-served basis, subject to the availability of fund.
3. When the Scheme is over-subscribed, the date on which the application is received by the Marine Department will be used to determine eligibility.
4. The effective date of Phase 2 & Phase 3 subsidy is 1st April, 2018, and the effective date of extending Phase 2 subsidy period from 6 months to 9 months is 1st December 2023.
5. If the Return Date of applicant is before the effective date of Phase 2 & Phase 3 but who can fulfil the following criteria may also apply for Phase 2 and Phase 3 incentive:
 - (i) Any portion of the 12 months from the Return Date of applicant falls on/after the effective date and all the eligible criteria of Phase 2 have been fulfilled, applicant may obtain no more than 9 months of the Phase 2 incentive from the effective date to the passing date¹ of examination, or to the last attempt of examination within the above-mentioned 12-month period.
 - (ii) If applicant has worked on board as cadet after obtaining of certificate of competency (CoC) that fulfilled the criteria of paragraph 14 below, and any portion of the working period of his/her cadetship working period that falls on/after the effective date, applicant may obtain the Phase 3 incentive for such period after the effective date.

6. The form should be completed in BLOCK LETTERS.
7. Application for Phase 2 and Phase 3 shall be submitted in person, by post/email to the Seagoing Examination and Mercantile Marine Office, Marine Department (Room 302, 3/F, Harbour Building, 38 Pier Road, Central, Hong Kong) upon their completion of required cadet sea-going training for examination, and before their first attempt of the Deck Officer Class 3 / Marine Engineer Officer Class 3 Examination. E-submission (e.g. via email sssem@mardep.gov.hk, mmd@mdd.mardep.gov.hk, eBS public form online submission) with scanned application and supportive documents is also acceptable, original documents shall be produced for verification in person or by post before the examination.

一般事項

1. 航海訓練獎勵計劃旨在鼓勵香港青少年接受及完成航海訓練，以發展他們未來在港口及海事支援行業的事業。
2. 視乎撥款情況，獎勵金將以先到先得的方式發放給成功的申請人。
3. 當該計劃收到超額申請時，將以海事處收到申請的日期決定資格。
4. 航海訓練獎勵計劃第2及第3階段資助由2018年4月1日起生效。第2階段資助由6個月提升至9個月自2023年12月1日生效。
5. 如申請人的回港日期在計劃第2及第3階段生效日期前，申請人如符合以下資格，仍可申領第2及第3階段的獎勵：
 - (i) 申請人於回港日期起計12個月有任何部份在生效日期或之後，並且符合所有其他申請第2階段的資格，申請人可由本計劃生效日起計，獲得不多於9個月的第2階段獎勵，至申請人在上述12個月內考試考獲合格²當日，或其回港日期起計12個月內最後一次參加的考試日為止。
 - (ii) 如申請人在符合以下第14段的規定下，在取得適任證書後在船上擔任實習生工作，同時該實習工作期間有任何部份在本計劃生效日或之後，申請人可就生效日後的工作期間獲得第3階段的獎勵。

6. 本表格應以正本大楷填寫。
7. 第2及第3階段的申請須在完成甲板高級船員三級/輪機師三級考試所需的實習生航海訓練後，參加第一次甲板高級船員三級/輪機師三級考試前，親自，以郵寄或電郵方式向海事處遠洋航行考試及商船海員管理處（香港中環統一碼頭道38號海港政府大樓3樓302室）提交申請。電子提交（如電郵 sssem@mardep.gov.hk, mmd@mdd.mardep.gov.hk, eBS公用表格網上遞交）掃描的申請及相關文件亦可，原件需於考試前親身或郵寄提交以核查。

Eligibility Criteria

8. The applicant has been successfully enrolled for incentive Phase 1.
9. The applicant has successfully enrolled for a Deck Officer Class 3 / Marine Engineer Officer Class 3 Examination held by the Marine Department of Hong Kong and the examination will be held within 12 months from the Return Date of the applicant.

Incentive Phase 2 – Preparation for Examination

10. After the cadet sea-going training period, applicant successfully enrolled for Marine Department Deck Officer Class 3 / Marine Engineer Officer Class 3 examination that to be held within 12 months from the Return Date may apply for the phase 2 incentive. Successful applicant will receive the incentive of HK\$3,000 per month from the Government while they are preparing for the examination on shore for a maximum of 9 months. Any claim to incentive will start to accrue from the Return Date to the passing date of examination, or the last attempt of examination within the above-mentioned 12-month period.
11. Subject to the principles set out in paragraph 10 above and depending on the timing when the applicant takes or passes the examination, incentive payment from the Return Date will be made by five installments at most. The first four installments will be paid in the 3rd, 5th, 7th and 9th month and fifth installment will be paid in the tenth month or after the first attempt of the examination, whichever is later. Depends on the continuous eligibility of applicant, each installment of incentive will be equivalent to 2 months of incentive or less on a pro rata basis for any incomplete month of shorter period.
12. If an applicant sits for the examination but fails in the Phase 2 incentive period, the incentive will be accrued up to the examination date. If the applicant has successfully applied to resit the same examination within the above-mentioned 12-month period, the incentive will be accrued up to the date of his/her last attempt of examination within the 12-month period, but will not exceed 9 months in total.
13. Applicants are required to sit for the Deck Officer Class 3 / Marine Engineer Officer Class 3 Examination within 12 months from the Return Date. The time limit for applicants who can produce reasonable proof that failure to attend was unavoidable and the reasons have been accepted by Marine Department for deferral of examination may be extended until the last examination date of the next round of examination. If an applicant fails to attend the examination within the above 12-month period without such reasonable proof, he/she will be required to pay back the Government all incentives already disbursed to him/her in this phase.

Incentive Phase 3 – Working On Board as Cadet after Obtaining of CoC

14. After the applicant has successfully passed the Deck Officer Class 3 / Marine Engineer Officer Class 3 Examination and obtained a Deck Officer Class 3 / Marine Engineer Officer Class 3 Certificate of Competency from Hong Kong Marine Department, the applicant will receive an incentive payment of HK\$6,000 per month from the Government in arrears as a lump sum on completion of each employment agreement up to a maximum of 6 months if he/she

8. 申請人已成功參加獎勵計劃第 1 階段。
9. 申請人已成功報名參加香港海事處舉辦的甲板高級船員三級/輪機師三級考試，而考試將於申請人回港日期後 12 個月內舉行。

獎勵計劃第 2 階段 - 考試準備

10. 實習生航海訓練結束後，申請人成功報考海事處甲板高級船員三級/輪機師三級考試，並且考試日期在其回港日期後十二個月內，即可申請獎勵計劃第 2 階段。成功申請人在岸上準備考試期間，每月可獲港幣 3,000 元獎勵，為期不超過 9 個月。獎勵申請權將由回港日期起計至申請人在上述 12 個月內考試考獲合格當日，或在上述 12 個月內最後一次參加的考試日為止。
11. 受限於以上第 10 段的原則，視乎申請人參加考試或考試合格的時間，獎勵在其回港日期起最多分五期發放，前四期分別在第 3 個月，第 5 個月，第 7 個月和第 9 個月發放，第五期將在第 10 個月或第一次考試後支付，以較後者為準。視乎申請人的持續資格，每期的獎勵金將相等於兩個月的獎勵，或在較短的情況下不足整月時，將按比例計算。
12. 如果申請人在第 2 階段獎勵期間參加考試但未能通過，獎勵將會計算至考試當日。如申請人成功在上述 12 個月內重考，獎勵將計至在該 12 個月內最後一次考試日為止，但總共不超過 9 個月。
13. 申請人必須在回港日期後 12 個月內參加甲板高級船員三級/輪機師三級考試。若申請人能夠提供合理證據證明未能出席是無可避免的，並且獲海事處接納為延期考試的理由，則有關時限可獲延長至下一輪考試的最後一天。如果申請人無合理證據證明其無可避免缺席在上述 12 個月內參加考試，則須向政府歸還已經向其發放的第 2 階段獎勵金。

獎勵計劃第三階段 - 取得適任證書後在船上擔任實習生工作

14. 申請人成功通過甲板高級船員三級/輪機師三級考試及從香港海事處取得甲板高級船員三級/輪機師三級適任證書後，若申請人獲聘請在遠洋船隻上擔任與該適任證書相同部門的甲板/輪機實習生，在該實習工作期間可獲得每月 6,000 港元的獎勵金。獎勵金將在申

Qualifying Sea Service for Incentive Phase 3

第三階段獎勵的合資格海上服務

15. Qualifying sea service must be performed as cadet in either deck or engine department of the same discipline of applicant's Certificate of Competency in a sea-going ship after the applicant obtains a valid Deck Officer Class 3 / Marine Engineer Officer Class 3 Certificate of Competency from Marine Department. The applicant must have never been employed as an officer of sea-going ships.
 16. Applicant must submit a written notification of joining a ship with the term of contract to Marine Department (email: mmo_mdd@mardep.gov.hk) before joining the ship. Only sea-service commencing after the date of receipt of the notification by the Marine Department can be considered eligible for Phase 3 incentive.
 17. If the eligible sea-service was not drawn up in terms of complete months, the incentive will be paid on a pro-rata basis.
 18. Completion of each employment agreement has to be certified by the employer. No payment of the incentive or any part thereof will be made to sea service of an uncompleted employment agreement. Marine Department will accept applicants with uncompleted agreement for the award of incentive if the agreement is terminated by mutual agreement between the company and the applicant and the reasons for the termination are not due to the dissatisfaction of performance of the applicant.
 19. Applicant must prove their sea service by providing the Seafarer's Employment Registration Book and written confirmation from their employer for verification. In the case of service performed in ships that are foreign ships where Seafarer's Employment Registration Book records cannot be provided, it is acceptable for the applicant to provide a written confirmation by the Master of the ships concerned, or by the Consul or some other recognized official of the country of registry.
 20. Sea service as entered in Seafarer's Employment Registration Book will be reckoned by the calendar months, that is, the time included between any given day in any month and the preceding day of the following month, both inclusive. The number of complete months from the commencement of the period, ascertained in this way, should be computed, after which the number of odd days should be counted. The day of which the employment agreement commences, as well as that on which it terminates, should both be included, all leave of absence excluded and all odd days added together and reckoned at thirty days to the month. The followings are examples:
28 June to 4 August = 1 month 8 days
15 August to 18 October = 2 months 4 days
15. 合資格海上服務必須是在申請人取得海事處有效的甲板高級船員三級/輪機師三級適任證書後，在遠洋船隻上擔任與申請人適任證書相同部門的甲板部或輪機部的實習生。申請人必須從未獲聘為遠洋船隻的高級船員。
 16. 申請人必須在上船工作前以書面通知海事處，並包括合約任期(電郵: mmo_mdd@mardep.gov.hk)。在海事處收到上船通知後的海上服務才可被視為符合發放第 3 階段獎勵的資格。
 17. 如果合資格的海上服務期並非整月，獎勵金將按比例支付。
 18. 每份僱用協議的完成必須由僱主證明，獎勵金將不會發放予未完成的僱用協議的海上服務或其任何部分。如果合約因公司與申請人之間的相互協議而終止，而終止的原因不是由於不滿申請人的表現所致，海事處將接受申請人在未完成的協議下的合資格海上服務以發放獎勵金。
 19. 申請人須提供海員僱用登記簿及其僱主的書面證明以核實其海上服務，如服務的船隻為外國船隻而未能提供海員僱用登記簿記錄，申請人須提供由該船隻的船長或該船隻註冊國的領事或認可公職人員書面確認方可接納。
 20. 海員僱用登記簿的海上服務將按曆月計算，即由某一個月的某日開始至下一個月的相應日子的前一天，首尾兩天計算在內。應先計算服務期間開始的完整月份數目，然後計算零散的日數。僱用協議開始的日期以及協議終止的日期都應包括在內，所有假期缺席不包括在內，所有零散的日數總計以 30 天計算為一個月。舉例如下：
6 月 28 日至 8 月 4 日 = 1 個月 8 天
8 月 15 日至 10 月 18 日 = 2 個月 4 天
