## 交通諮詢委員會職權範圍

交諮會依照以下原則,就各項交通事務向行政長官會同 行政會議提供意見:

- 交諮會負責為交通政策廣泛涉及的各項問題,向行 政長官會同行政會議提供意見,以改善本港客貨運 流通的情況。
- 交諮會可就其職權範圍內任何事務,與市民大眾或 任何團體聯絡。
- 交諮會可研究與交通直接有關的財政問題,但涉及 公共開支及税務的方案,則由政府當局全權負責提 出。
- 環境運輸及工務局局長得為交通諮詢委員會提供秘 書處,負責有關的行政工作。
- 交諮會可下設小組委員會、與其他團體組成聯合委員會,以及增選成員執行特定任務,並可以其認為 最適當的方式組織工作。
- 政務司司長與交通諮詢委員會及行政長官會同行政 會議協商後,可不時修改委員會的職權範圍。

## Terms of Reference of the Transport Advisory Committee

To advise the Chief Executive-in-Council on transport matters in accordance with the following principles -

- The TAC's function is to advise the Chief Executivein-Council on broad issues of transport policy with a view to improving the movement of both people and freight.
- On any matter within its terms of reference, the TAC is free to communicate with members of the public and with any organisation.
- The TAC may consider financial matters where they directly relate to transport, but the responsibility for proposing public expenditure and taxation lies solely with the Administration.
- The Secretary for the Environment, Transport and Works will provide a secretariat for the TAC and will be responsible for administration in connection with it.
- The TAC will be free to form sub-committees, to participate in joint-committees with other bodies, and to co-opt members for specific purposes. It may organise its work in whatever manner it considers most suitable.
- The Chief Secretary for Administration may, after consultation with the TAC and the Chief Executivein-Council, amend the terms of reference from time to time.
